1. Mr. Poppe was awarded 10,952 Restricted Stock Units ("RSU's). Each RSU represents a contingent right to receive one share of common stock. The RSUs vest in four equal annual installments beginning on May 30, 2013. Vested common stock shares will be delivered to the reporting person within thirty days following the date of the vesting of the shares. The RSUs may be settled only by delivering of shares of Conn's Inc Common Stock, and thus, the grant is being reported on table I as allowed by SEC guidance
